(teams of less than 6 members will be disqualified)  

A Zone:	Teams comprised of advanced-level competitors.
B Zone:	Teams comprised of players 55 years of age and under
C Zone:	Teams comprised of players 56 years of age and over
D Zone:	Teams comprised of players 66 years of age and over

Age determined by the first day of the tournament, October 17, 2008.

Any change of player's entry should be notified to OCBC by September 30, 2008.

8. Competition method: All teams will play a round-robin, pool play format consisting of four to five teams in each pool. The winning team of each pool (and in some cases the second-place team in a pool, depending on the number of pools/groups) will advance into the main-draw competition.
9. Rules: In accordance with the playing rules and management regulations of the Osaka Ladies Badminton Federation and the Badminton World Federation (BWF) 21 points.
10. Qualifications: Female 23 years and older for B-D Zone. A Zone competition has no age restrictions.
11. Shuttlecocks: Yonex AS-50 feather shuttlecocks sponsored by Yonex USA.
12. Award: A Zone 1<sup>st</sup> place US\$2,000, 2<sup>nd</sup> place US\$1,500, and 3<sup>rd</sup> place US\$1,000, plus medals.  
B-D Zone will receive medals.
13. Entry fee: US\$200 per one team (check or credit card accepted)  
Overseas teams are free from the entry fee  
  
All players will receive tournament t-shirt.

6 I hereby grant to USA Badminton, its licensees and contractees including photographers, television and motion picture companies, their affiliates and subsidiaries, full television and motion picture rights including authority to film or videotape me during matches, narratives, personal interviews, or comment thereon for any and all commercial, news or other purposes together with the right to transfer or grant their rights to others, all without remuneration or compensation to me whatsoever.
