**Eligibility:** The 2005 USBDF Winter Junior International is open to all badminton junior players.

US players must have USAB membership, which can be purchased at the tournament.

**Awards:** Medals will be awarded to champion, runner-up, and consolation winner.

## **Conditions:**

- 1. The tournament will be conducted in accordance with applicable IBF and USAB rules.
- 2. Events may be combined or played round robin format if not enough entries are received.
- 3. Consolation draws will be held for each event.
- 4. Up to two Yonex feather shuttlecocks per match will be provided free of charge.
- 5. All matches will be played in the best 2 of 3 games to 15 pts. for BS, BD, GD, MX and to 11 pts. for GS.
- 6. A player not ready to play ten minutes after his/her match is called will be defaulted.
- 7. On court warm-ups is limited to 5 minutes.
- 8. The 2005 US Junior's National results will be used for seeding arrangement.
- 9. Each player in a doubles partnership must submit separate entry forms.
- 10. Entries will not be refunded if cancelled after December 2, 2005.
- 11. The Tournament Director reserves the right to change any of the above conditions.
